

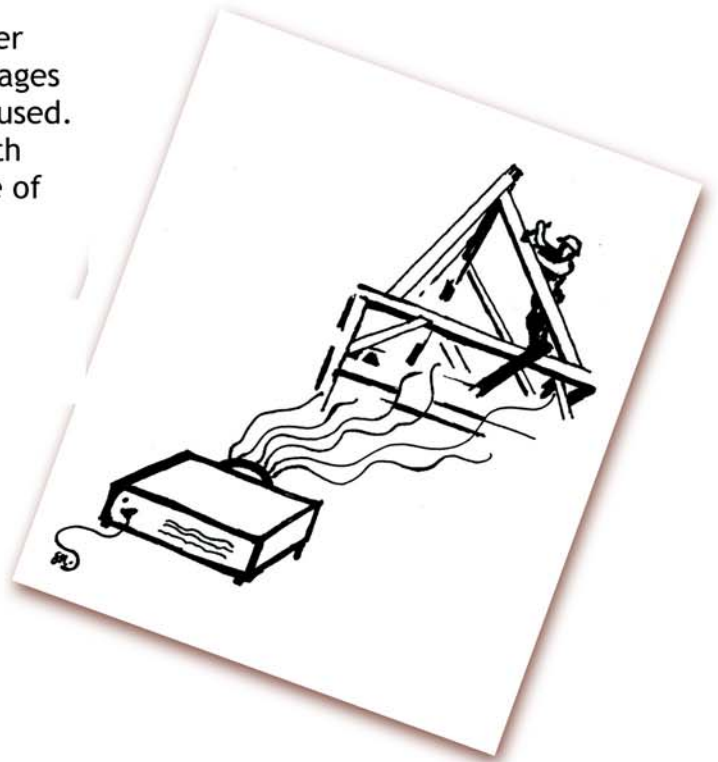


THE SLIDE SHOW

General Guidelines

- Presenters may show up to ten images of recent timber framing work.
- Images must be of work in which you have actively and directly participated.
- You must be present to talk about your images.
- No commercial logos are permitted.



Preparation

- Images may be of one project or of several, and must involve timber framing
- Images may be presented through the preferred digital format or through slides; digital submissions may be on CDs, DVDs or memory sticks.
- Label your CD or slides with your name and contact information.
- Number your images in the order in which you wish them to appear.
- Label slides with "top" and "front"
- Digital presenters please use two-digit file names to achieve the proper image order: YES: "01.jpg" NO: "1.jpg". Though jpeg formats are preferred, most others will work.
- *No more than 10 images!*

Submission

- Leave entries at the TFG conference registration desk as early as possible and PLEASE by noon on Friday.
- Submit the publishing agreement (see reverse) if you wish to be considered for publication. Copies are also available at the TFG desk.

Presentation

- You will narrate your images.
- Images will be presented generally in the order in which they are received.
- Watch for your name in the group lists on screen and move to the front of the room to be ready to present.

TIMBER FRAMERS GUILD PUBLISHING AGREEMENT

Thanks for contributing to the success of the slide show at the Timber Framers Guild Conference. We are contemplating publishing this and future slide shows complete with audio in electronic formats via the web and other electronic media. We need your permission to include your work and your words in these compilations. Please review this agreement and sign it if you can. There is no penalty or consequence for being unwilling or unable to sign; perhaps you do not have the rights to all of your images, for instance. We're OK with that.



1. **Publication Rights.** _____ (the Author) grants to the Timber Framers Guild (the Guild) the rights to publish the audio and visual materials presented at the conference slideshow by the author, photographer or his or her agent. These rights include (1) the non-exclusive right of one-time publication of the materials in any medium of the Guild's choice including but not limited to print, Web or electronic media; (2) the non-exclusive right to republish the materials or any part of them in any Guild publication in any medium including but not limited to print, Web, electronic or other medium now or hereafter available; (3) the non-exclusive right to republish the materials in any publication in any medium promoting the activities of the Guild.
2. **Rights Reserved.** The Author reserves all rights not granted to the Guild. The Author may without accompanying notice to the Guild publish or grant others the right to publish the materials at any time before or after publication of the materials by the Guild.
3. **Publisher's Obligations.** The Guild will identify and credit the Author in any publication or republication of the materials and will direct to the Author any requests for republication by other publishers.
4. **Author's Warranties.** The Author warrants that the Materials provided were created by the author and/or that the author has the right to grant publication rights to the Guild. The author warrants further that the materials do not infringe upon any copyright or intellectual property right. The Author shall defend, indemnify and hold harmless the Guild from all claims arising out of the Author's breach of said warranties.
5. **Changes to the Agreement and Dispute Resolution.** This agreement may be amended only in writing by both parties and shall be governed by the laws of the Commonwealth of Massachusetts. Should any dispute arise with regard to this contract, at the request of either party it may be decided by arbitration conducted in accordance with the rules of the American Arbitration Association.
